The Community Foundation of NCW is one of the only resources for grant-seeking nonprofits in our region. Through the Community Grants Program, nonprofit organizations can apply for financial support to improve and enhance our communities.

The Community Foundation of NCW offers a variety of giving tools to help carry out your charitable dreams. We provide professional fund management, grant making assistance, and personalized, tailored giving services to every donor. Our goal is for you to enjoy all the rewards of giving and leave the rest to us.

### FLEXIBLE GIVING

**Donor Advised Funds** are like having your own foundation. They allow you (or a designee) to serve as advisor to recommend grants from the fund. The fund is invested for growth, so when you're not giving it away, it's growing! During high-income years, establishing a Donor Advised Fund (DAF) can offer tax-smart benefits. They also include succession plans allowing your charitable assets to work for you beyond your lifetime.

### **BUILDING FUTURES**

**Scholarship Funds** provide a rewarding charitable giving experience. Each year, our foundation receives over 1,500 applications from students across North Central Washington who are in need of financial assistance to attend college, university, or a trade school. Every scholarship is unique: you determine the criteria. Whether you want to support students in a specific area or heading to your alma mater, or giving someone a second chance – starting a scholarship fund gives you an opportunity to significantly and directly impact someone's life. Awarded annually, a scholarship committee selects recipient(s) based on the criteria you set. Your participation in the selection process is optional.

### KEEPING IT LOCAL

**Legacy Funds** provide annual grant funding to qualified nonprofits in specific geographic areas. Each fund has its own Local Advisory Board that draws upon its knowledge of the area to determine grant awards that have the biggest impact in their community. A gift to a Legacy Fund, during your lfietime or through a bequest, will help build the endowment and increase the grant award allotment each year.

To honor his contributions to the Upper Valley, we are making this gift to the Upper Valley Fund to continue his legacy. We hope that others will contribute to this fund, either the long term endowment or immediate use."

A gift to a Legacy Fund may be dedicated towards the annual grant funding or it can be endowed to help the fund grow in perpetuity and increase the award allotment each year.

### FAVORITE CAUSES

**Designated Funds** are for people who want to financially support one or more specific charitable organizations on a regular basis. This allows ongoing giving to the causes you are most passionate about during your lifetime and beyond. Simply choose one or more charities you want to support and they receive your gift annually in your fund's name.

**Field of Interest Funds** allow your contribution to support the many organizations that are working to improve and enhance a particular area of interest (such as the arts, environment, or education) but leaves the selection of the grant recipients to us.

### PARTNERS IN GIVING

Partners in Giving provide unrestricted support for the ongoing programmatic activities of the foundation. PIGs (as we lovingly call them) give a boost to our annual grant making awards, help round up our scholarships, and promote community philanthropy by supporting the online crowd-funding campaigns benefitting hundreds of nonprofits throughout the region. PIG dollars also help the foundation launch new initiatives such as the Leadership Institute of NCW and respond to urgent needs and emergencies in our communities.

### Ways to give. Today and forever.

Your Community Foundation offers many ways to thoughtfully plan your charitable giving today and beyond your lifetime. Leaving even a small portion of your estate will make a lasting impact in your community and to the causes you care about - *forever*. We can work closely with your professional advisors on your giving opportunities and develop a plan that is meaningful for you.

**Gifts of Stock** Giving a gift of publicly traded stock that has increased in value and that you have owned for more than one year may provide better tax benefits than giving cash. When you gift publicly traded stock, your charitable income tax deduction is equal to the fair market value of the stock and you avoid paying the capital gains tax on any increase in the current value over the original cost of the stock.

**Qualified Charitable Deducation (IRA) and Giving Cards** Gifts from your IRA Qualified Charitable Distribution (QCD) may be applied to most funds at the Community Foundation or we can accept the gift and pass it on to one or more qualified nonprofits (eg: 501c3 public charity, school, government agency).

**Bequests** A bequest allows you to make a provision in your Will, Estate Plan, or Living Trust for a gift to the Community Foundation. The gift may be a specified dollar amount, percentage, or the remainder of your estate after providing for your family and friends. The gift can be unrestricted, or can be established as a named fund of your choice.

**Donor Advised Fund Succession Plans** are a valuable tool for your charitable estate planning. Simply name your Donor Advised Fund (DAF) in your estate plan, then work with us to create a Succession Plan to determine what happens with those charitable assets. The Succession Plan is highly flexible – you can keep some funds in the DAF for your heirs to advise, you can create a scholarship fund, or a designated fund to benefit your favorite charities, or a field of interest fund to support a particular cause – or any combination thereof. The best part is that you incur no legal fees when you work with us on this plan and can revise it, free of charge, at any time.

**Charitable Remainder Unitrust (CRT)** is a separate legal entity managed by a Trustee (such as the Community Foundation). The CRT provides an annual income to the named beneficiary(ies) for a term of years, or life. The remaining assets at the end of the term of the Trust are used to establish a named fund at the Community Foundation that fulfill your charitable goals. A CRT allows you to give an asset such as cash, securities or real estate, which is then reinvested and provides an immediate income tax and capital gains benefit.

**IRA/Life Insurance Beneficiary** Designating the Community Foundation as a beneficiary of an IRA is an excellent way to make a testamentary gift to charity and take advantage of a tax deferred asset in an estate plan. Life insurance gifts include gifting a premium paid policy outright or adding the Community Foundation as a beneficiary. For new or existing policies where a premium is due, making the Community Foundation the owner and beneficiary will result in a current income tax deduction as well as an annual deduction for the premium payment. Both types of Life Insurance gifts provide potential estate planning benefits.

Working with Professional Advisors is important in your charitable giving plans. Whether it's your attorney, financial advisor, or CPA, we partner to make sure that your philanthropic interests are met with maximum benefits. ### **Heirloom Society**

The Heirloom Society was established to honor individuals and families who have committed to leaving a legacy to future generations through the Community Foundation.



#### Consider the definition of *heirloom*:

- a piece of property (such as a deed or charter) that descends to the heir as an inseparable part of an inheritance of real property;
- something of special value handed down from one generation to another;
- a variety of plant that has originated under cultivation and that has survived for several generations usually due to the efforts of private individuals.

Joining the Heirloom Society allows us to honor and thank you for caring for the future of NCW during your lifetime and help ensure your charitable work continues beyond your lifetime. There are no dues or other obligations, but as a member you will be kept informed of the work of the Community Foundation and included in special events and programs.
