The Okanogan Valley Fund Local Advisory Board, comprised of Okanogan Valley residents, volunteer their time to review and recommend grant awards to ensure they support urgent and impactful causes throughout the valley.

As gifts are added to the fund, the annual amount available to disburse in grants grows and helps provide continual and permanent financial resources that exclusively benefit the Okanogan Valley.

Tambra comes from strong Okanogan roots. Her mother was born in 1939 in Okanogan County, the only daughter alongside three spirited brothers. Her father was a local Sheriff during prohibition and has stories made for movies and campfires.

Tambra's love for the area extends back to her grandfather and the Border Lord mine in the Pasayten wilderness. Its history captured her, especially the 25-mile race through snow her father ran in snowshoes, vying for rights of the mine. Later, she would follow her mother, a wilderness ranger, to the mine through the Pasayten. Later again, Tambra would chaperone her son's high adventure 50-mile scout trip that he embraced.

When the time came for Tambra and her husband Peter to retire, they revisited the valley. While some things changed, its beauty and strong community didn't.

A LEGACY GIFT

Raised in Cashmere and a graduate of Eastern Washington University, John E Andrist was the owner and publisher of the Omak-Okanogan County Chronicle from 1970-1996. He was a respected leader in the community and among his newpaper peers. In 1979, he married Mary Koch, a former Associated Press editor, who joined him in life in Okanogan County and in their mutual love of community journalism. John passed in 2007.

Mary had always dreamed of helping to establish a fund where people could donate to directly benefit the charitable causes across the Okanogan Valley. Through her will, she has directed the remaining funds to support the Okanogan Valley Fund upon her passing - leaving a legacy from both her and John to the community they cherished.

"These funds can empower organizations, largely run by volunteers, and support their efforts with concrete funding they wouldn't have otherwise."
